My reflections:

Positive: we had a very compatible team. We each brought different skills to the role but all had a passion in different ways for language as well as familiarity with the Quaker decision making process and culture. This is important on or offline, but online in addition we needed a facility with digital tools in the mix in at least one member to make it work - and preferably more than one. We had that too.

Another positive for me and at least one other member was the ease of audibility online. And the privacy of the Zoom meeting.

A potential challenge was the need to get references and names correct. We were fortunate that you foresaw the need for one quote and responded promptly when we needed a second. Sending the draft YM minutes to the EC would be a good ongoing practice in case they are needed. Online you are under a lot of time pressure because of not having meals provided, and urgent contact with people who don't regularly check messages is not so easy.

We had really useful feedback, both in real time and via the email, especially towards the end. We needed that as, when operating online under time pressure, you can't just shoulder tap people to get input. You rely on them to initiate and respond quickly, with an awareness that the text really needs to be finalised, preferably well before, and certainly by the opening of the final session.

It really helped that the agenda for the last one and a half sessions was less likely to provide epistle material, being in the nature of reporting on work already completed and reflected on elsewhere.

That's my 'two pennith worth'. Hope it's helpful.

Pastoral Care

Reflection of YM 2022 from a PSCC perspective.

We found that YM ran very well. This was a new experience for us all and we appreciate the preparation beforehand and the way you were able to respond to various challenges that might have been more stressful than it appeared to us.

Comments we would like to make are:

when members of PSCC were appointed it could have been helpful to identify a convener.

In future this may help PSCC in coordinating their respective duties and responsibilities remotely. Having the open Zoom Room available to PSCC worked well.

PSCC provided a couple of members after each session (and associated sessions) in designated breakout rooms. This worked well, however we learnt that it would have been better for us to schedule that role rather than it being an ad hoc arrangement.

There were no serious concerns brought forward to us at YM.

As we were attending from home it meant that we were distracted at times by things that we would have left behind if we were gathered together.

We also noticed this in others, some however were rather prone to log into the meetings before they had properly arranged a quiet space at home.

We would like to be allowed to be admitted into the meeting from 15 minutes before the "start time". It felt rather unnatural to all come in en masse.

When those appointed to PSCC and R&S were introduced at the beginning of YM the words used in the second document for registrants:

"If you are finding the online experience or anything else about Yearly Meeting uncomfortable or upsetting, please contact one of our Pastoral and Spiritual Care Friends."

would be suitable. An appropriate introduction for the R&S contacts needs to be developed so Friends know what their role is intended to serve.

A couple of small matters around ministry from Friends: there should be consistent use of name and Meeting by those asked to speak and when a Friend has finished presenting a report they should allow the clerks to manage the subsequent questions.
